DECISION

for the commencement of work on the study programs of the first cycle of three-year studies and the second cycle of two-year studies in Tourism at the Faculty of Tourism, Human Resources Management at the Faculty of Human Resources Management, Entrepreneurial Business at the Faculty of Entrepreneurial Business, International Marketing and Management at the Faculty of International Marketing and Management Economics at the Faculty of Economics at the Private Higher Education Institution - University of Tourism and Management in Skopje

This decision confirms that the conditions for the commencement of work of the study programs of the first cycle of three-year studies and the second cycle of two-year studies in Tourism at the Faculty of Tourism, Human Resources Management at the Faculty of Human Resources Management, Entrepreneurial Business at the Faculty of Entrepreneurial Business, International Marketing and Management at the Faculty of International Marketing and Management Economics at the Faculty of Economics at the Private Higher Education Institution - University of Tourism and Management in Skopje have been met

Explanation

Following the information received by the Accreditation Board, Decision no. 15-172/4 from 18.12.2014 on accreditation of the study program Tourism, first cycle three-year studies at the Faculty of Tourism, Decision No. 15-172/5 from 18.12.2014 on accreditation of the study program Tourism, second cycle two-year studies at the Faculty of Tourism, Decision No. 15-172/12 from 19.12.2014 on accreditation of the study program Human Resources Management, first cycle three-year studies at the Faculty of Human Resources Management, Decision No. 15-172/13 from 19.12.2014 on accreditation of the study program Human Resources Management, second cycle two-year studies at the Faculty of Human Resources Management, Decision No. 15-172/10 from 18.12.2014 on accreditation of the study program Entrepreneurial Business, first cycle three-year studies at the Faculty of Entrepreneurial Business, Decision No. 15-172/11 from



18.12.2014 for accreditation of the study program Entrepreneurial Business, second cycle two-year studies at the Faculty of Entrepreneurial Business, Decision No. 15-172/7 from 18.12.2014 for accreditation of the study program International Marketing and Management, first cycle three-year studies at the Faculty of International Marketing and Management. Decision No. 15-172/6 from 18.12.2014 for accreditation of the study program International Marketing and Management, second cycle two-year studies at the Faculty of International Marketing and Management, Decision No. 15-172/8 from 18.12.2014 for accreditation of the study program Economics, first cycle three-year studies at the Faculty of Economics and Decision No. 15-172/9 from 18.12.2014 for accreditation of the study program Economics, second cycle studies at the Faculty of Economics. The private higher education institution University of Tourism and Management in Skopje, submitted a request No. 03-430/1 from 17.12.2014 to the Ministry of Education and Science, under our No. 13-20319/1 from 22.12.2014, to determine the fulfillment of the conditions for the start of the study programs of the first cycle of three-year studies and the second cycle of two-year studies.

The Ministry of Education and Science, by Decision 13-20319/2 from 24.12.2014, established a Commission for Determining the Fulfillment of the Conditions for Starting Work.

On 26.12.2014, the Commission inspected and prepared Report No. 13- 20319/3 from 29.12.2014, which confirmed that for the study programs of the first cycle of three-year studies and the second cycle of two-year studies in Tourism at the Faculty of Tourism, Human Resources Management at the Faculty of Human Resources Management, Entrepreneurial Business at the Faculty of Entrepreneurial Business, International Marketing and Management at the Faculty of International Marketing and Management, and Economics at the Faculty of Economics at the Private Higher Education Institution - University of Tourism and Management in Skopje, the conditions have been met in accordance to the provisions established by the Law on Higher Education and the Decree on Norms and Standards for the Establishment of Higher Education Institutions and for the Performance of Higher Education Activities ("Official Gazette of the Republic of Macedonia" No. 103/10, 168/10 and 10/11).

Taking into consideration all that has been stated before, it was decided as in the dispositive part of this decision.
