Upon art 32 and 71 item 2 line 4 from the Law for high education ("Off. Gazette of RM" No.35/2008), the Committee for accreditation on its 22<sup>nd</sup> session, held on 19.11.2009 has brought

### DECISION

for accreditation of the Project for founding of the private high education institution  
University of tourism and management – Skopje

1. It is accepted and accreditation is given to the Project for founding of 5 faculties on private high education institution University of tourism and management – Skopje, according to the Law for high education, the Rulebook for normative and standards for founding of the high education institutions and for performing of high education activity.
2. Accreditation from the item 1 of this decision is given for studies program of:
  - Faculty of entrepreneurship
  - Faculty of management of human resources
  - Faculty of international marketing management
  - Faculty of sport tourism
  - Faculty of public relations

Upon the finishing of the three years, the student that finished faculty program on the named faculties, obtains a right of diploma:

- Graduated manager of entrepreneurship
  - Graduated manager of human resources
  - Graduated manager of international marketing management
  - Graduated manager of sport tourism
  - Graduated manager of public relations
3. The founder have the duty fully to realize the Project under the item 1 of this decision upon the finishing of the conditions for performing of high education activity in accordance with the Law for high education, the Rulebook for normative and standards for founding of the high education institutions and for performing of high education activity (Off. Gazette of RM 33/03).

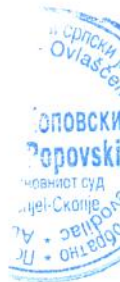


4. The founder may announce the competition and to execute enrollment of the students after the completing of the procedure for founding of the new faculties from item 3 of this decision in accordance with the Law on high education that is after the getting of the decision for start with works by the Ministry of education and science and will execute enrollment in the Register of high education institutions of the Republic of Macedonia, as well as in the court register at the competent court and after the completing of this situation the University obtains a right to perform high education activity of the newfound faculties.
5. According to the conditions given in the project for founding of the five faculties in the composition of the University of tourism and management – Skopje, the total number of the students on the new faculties can be axiom up to 300 students per year.
6. With the day of entering into force of this decision, the founder have the right to overtake all of the activities for implementation of the project for founding of the new faculties in the framework of the University for tourism and management – Skopje and to inform the public for the content of this decision as well as for the activities which are overtaken for founding of the new faculties in the framework of the University.
7. The founder does not have the right to use this decision for informing of the public that the procedure for founding of the new faculties has been finished in the framework of the University and that the conditions for performing of high education activity are fulfilled, neither on any way to bring in misapprehension the public for start of enrollment of the students.
8. The accreditation of item 1 of this decision gives a right of the founder to continue with the preparation work for founding and constituting of the new faculties in the framework of the University with right to start the education in the school 2008/2009 or later under the conditions determine with this decision.
9. The decision came into force with the day of the making of the decision and will be applicable with the day of the given finance guarantee according to the Law.

#### EXPLANATION

After the giving of the application by the University of tourism and management – Skopje, for acceptance and accreditation of the Project for founding of 5 faculties on the private high education institution the University of tourism and management – Skopje, the Accreditation Board creates an expert commission that prepares an expert report and the same was delivered to the members of the Accreditation Board.

The Accreditation Board has accepted the project and accreditation was given to the elaborate for founding of 5 faculties within the framework of the University of tourism and management – Skopje, and on the base of fulfillment of the conditions in accordance with the Law for high





education, the Rulebook for normative and standards for founding of the high education institutions and for performing of high education activity.

The Accreditation Board on its 67<sup>th</sup> session held on 26/02/2008, have a discussion upon the request of the private high education institution University of tourism and management – Skopje, and after the deliverance of the given documentation and the report of the expert commission make the decision as in the introduction of this decision
